BIOGRAPHY

Monika Milošević was born in Belgrade. She finished her primary school and high school in her hometown with outstanding success. In 1992, she enrolled at the Faculty of Law of the University of Belgrade, where she graduated with an average grade of ten (10). In the first year of the Faculty she wrote and defended a seminar paper for the Legal History course under the title "The emergence and organization of the Old Jewish State", which was declared the best seminar work of that year at the Faculty of Law, University of Belgrade.. During the second year of the faculty, she won the first prize at the Oratory Competition, held at the Faculty of Law, University of Belgrade. At the final year of the faculty, she wrote and defended a seminar paper on Civil Procedure Law, titled "Composition of the Court". During 1997 and 1998, she worked for seven months as a judicial trainee at the Fourth Municipal Court in Belgrade, in civil, non-contentious, executive and inheritance cases. During the 1997/98 school year, she enrolled in postgraduate studies at the Faculty of Law, University of Belgrade. During that period, she wrote a seminar paper, under the title "Withdrawal of the Claim". In July 1998, she was elected as the Teaching and research assistant for the Civil Procedure course at the Faculty of Law, University of Belgrade.

She passed the oral Master's exam in 2000, and her Master's thesis "Environmental protection and environmental lawsuit in the United States" was defended on December 26, 2003, at the Faculty of Law, University of Belgrade. The mentioned Master's thesis was published in the form of a monograph in December 2004. She was visiting scholar at the Suffolk University Law School, Boston, Massachusetts, U.S.A., during the 2001 / `02 school year. Next school year Monika Milošević attended LL.M. program at the Suffolk University Law School, Boston, Massachusetts, U.S.A., where she obtained title Master of Laws in Global Technology . In December 2003 she was elected as the Teaching and research assistant with Master title for the course Civil Procedure at the Faculty of Law, University of Belgrade. She also taught the Introduction to Civil Law.

On May 16, 2006, she defended her PhD thesis: "Subjective limits of the final judgment". In November 2006, she was elected as the Assistant Professor for Civil Procedure at the Faculty of Law, University of Belgrade. In 2007, she was elected as the Assistant Professor for Environmental Law. She has participated in numerous international and domestic seminars and conferences. Monika Milošević completed her training for negotiation skills trainers organized by the SEDP-Serbia Enterprise Development Project and training for future mediators, organized by the International Finance Corporation-World Bank Group.

Since 2011, she works as an Assistant Professor at the Faculty of Law, Union University for courses Civil Procedure, Mediation, Torts and Contracts and Environmental Law. In 2013, she was elected as an Associate Professor. From 2012 to 2015, she served as the Vice Dean for Academic Affairs. She also teaches at doctoral studies, courses Civil litigation and executive
